The Governor of Haryana is pleased to accord the approval of qualification standards for different subjects in applied Sciences for Chaudhary Devi Lal Memorial Government Engineering College, Panniwala Mota, (Sirsa), Rao Birender Singh State Institute of Engineering & Technology, Zainabad, (Rewari) and Ch. Ranbir Singh State Institute of Engineering & Technology, Silani, Kesho, (Jhajjar), as per the UGC/AICTE guidelines as follows:

Professor

- i. An eminent scholar with Ph.D. degree in the concerned / allied / relevant discipline with Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in the relevant discipline/subject and published work of high quality actively engaged in research with evidence of published work with a minimum of 10 publications as books and / SCI indexed refereed papers with impact factor not less than 2.00.
- ii. A minimum of ten years of teaching experience in university/ college, and / or experience in research at the University/ National Level Institutions/ industries, including experience of guiding candidates for research at doctoral level.
- iii. Contribution to educational innovation, design of new curricula and courses, and technology-mediated teaching learning process.
- iv. A minimum score as stipulated in the Academic Performance Indicator (API) based/ Performance Based Appraisal System (PBAS), as per regulations of UGC/AICTE.

OR

An outstanding professional, with established reputation in the relevant field, who has made significant contributions to the knowledge in the concerned/ allied/ relevant discipline, to be substantiated by credentials.

Associate Professor

- i. Good academic record with a Ph.D. Degree in the concerned/ allied/ relevant discipline with Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) in relevant discipline or subject.
- ii. A minimum of eight year of experience of teaching and /or research in an academic/ research position equivalent to that of Assistant Professor in a University/ College of Accredited Research Institution/ Industry, excluding the period of Ph. D. research with evidence of published work and a minimum of 5 publications as books and/ SCI indexed refereed papers with impact factor not less than 2.00.
- iii. Contribution to educational innovation, design of new curricula and courses, and technology- mediated teaching learning process with evidence of having guided doctoral candidates and research students.
- iv. A minimum score as stipulated in the Academic Performance Indicator (API) based/ Performance Based Appraisal System (PBAS), as per Regulations of UGC/AICTE

Assistant Professor

- i. Good academic record as defined by the concerned university with at least 55% marks (or an equivalent grade in a point scale whenever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign University.
- ii. Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC.
- iii. Notwithstanding anything contained in sub-clauses (i) and (ii), candidates, who are, or have been awarded a Ph.D. Degree in accordance with the AICTE/University Grant Commission (Minimum Standards and Procedure for Award of Ph.D. Degree Regulations, 2009), shall be exempted from the requirement of the minimum eligibility condition of NET for recruitment and appointment of Assistant Professor or equivalent positions in all three Government Engineering colleges in the state.
- iv. NET shall not be required for such Masters Programmes in disciplines for which NET is not conducted.

No person shall be appointed to any post in the regular service, unless he/she is in possession of minimum qualifications, and experience as per AICTE/UGC norms and as approved by Competent Authority.
