Subject. Regarding adoption of various recommendations of the UGC & MHRD with regard to minimum qualifications for appointment of teachers and other academic staff in the Technical Universities and measures for the maintenance of the standards of Technical Education.

In continuation of the Memo No. 25/1/2012-4TE dated 9.02.2012, the letter No. KW-7/18-2009 C-IV(3) dated 21.07.2011 issued by Director-General, Higher Education Department will be applicable mutatis mutandis for the three Technical Universities, with the following modifications.

1. Minimum qualifications for appointment of teaching faculty in the Technical Universities will be same as prescribed by UGC Regulations No. F.3-1/2009 dated 30 June 2010, as amended from time to time. In case a particular subject does not figure in the said regulation, AICTE prescribed qualifications in notification No. F.No.37-3/Legal-2010 dated 05 March 2010, as amended from time to time will be followed.
2. Short Term Courses of duration not less than a week with a total period of such Courses being atleast 56 days will be considered as equivalent to Refresher and Orientation Courses for promotion under CAS. These Short Term courses should be duly approved by UGC/AICTE.
3. Distance Degrees which are not approved by the Joint Committee of UGC, DEC and AICTE/ DEC shall not be considered for appointment at any level in the Universities/ Colleges.
