

AGREEMENT BETWEEN STATE GOVERNMENT AND CH.DEVI LAL MEMORIAL TECHNICAL EDUCATION SOCIETY PANNIWALA MOTA, (SIRSA)

Preamble

The State Government has decided to set up a college for imparting instruction and promotion of research and development activities in various branches of sciences, engineering and technology and management at village Panniwala Mota(Sirsa), Haryana. The college shall be named as Ch. Devi Lal Memorial Engineering College, Panniwala Motta. For setting up of the college and managing and maintaining the same on day to day basis, the State Government has set up a Society under the name and style of Ch. Devi Lal Memorial Technical Education Society, Panniwala Motta, Sirsa and the said Society has been, registered under the Society Registration Act, 1860.

This agreement made on this <u>day of Africh</u>, <u>6</u>th day of two thousand four BETWEEN the Governor of Haryana through Principal Secretary to Government, Haryana, Department of Technical Education (hereinafter referred to as "the State Government") one part AND the Ch. Devi Lal Memorial Technical Education Society, Panniwala Mota, (Sirsa) with its Registered Office at Chandigarh (hereinafter referred to as "the Society") the other part.

NOW, THERFORE, THIS AGREEMENT WITNESSES AS follows:-

- (a) The parties hereto hereby agree that Ch. Devi Lal Memorial Engineering College (hereinafter referred to as the "College") shall be established and maintained at Panniwala Mota, District Sirsa.
 - (b) The institute shall be established on a developed piece of land measuring 33 acres 7 kanals and 9 marlas which has been provided free of cost by Gram Panchayat, Panniwala Mota, District Sirsa, to the Department of Technical Education Haryana and any other land that the Department and or the societies may acquire.

- (c) Income shall be retained and used for the development of the College. The deficit occurred thereon shall be borne by the State Government through the budget of the Department of Technical Education on block grant basis.
 - The entire property of the College except land & building shall vest in the Society and the same shall be used exclusively for the purpose of the College. The State Govt. shall be the owner of the land & building used by the society.

The objects for which the Society has been established are as under:-

(a) Promotion of Technical Education:

- (i) To impart and provide for instruction, research and promotion in such branches of sciences, Engineering and Technology and Management as the institute may think fit for the advancement of learning and dissemination of knowledge in such branches. Primarily, the imparting of instructions shall be evolved on the broad principles of practice based on all branches of Engineering, Sciences and Management.
- (ii) To institute awards, fellowships, scholarships, prizes and medals in accordance with the rules and bye-laws.
- (iii) To fix and demand such fees and other charges as are prescribed by State Government in accordance with the guideline policy prescribed by the All India Council for Technical Education.
- (iv) To establish, maintain and manage hostels/residences of the students and the staff.
- To supervise and control the residents, regulate the discipline among the students and to make arrangements for promoting their general welfare, cultural and corporate life.
- (vi) To create administrative, technical and ministerial and other posts with the approval of the State Government and to make appointments

thereto and to regulate their recruitments, training, promotions, demotion and discharge under the rules and bye-laws of the Society.

- (vii) To collaborate with the Industry and Educational Institutions in any part of the world having objects wholly and partly similar to those of the Society by exchange of teachers, scholars and generally in such manners as may be conducive to their common objects.
- (b) To make rules and bye-laws within the scope of the constitution of the Society for the conduct of the affairs of the Society and to add or to amend, vary or to rescind these from time to time as the exigencies of the situation may demand and require, with the approval of the State Government.
- (c) To maintain a fund to which shall be credited:-
 - (i) all money provided by the Central Government, State Government and other agencies such as All India Council for Technical Education, University Grants Commission etc;
 - (ii) all fees and other charges received by the Society; and
 - (iii) all money received by the Society in any other manner or from any other sources.
 - (d) To deposit all money credited to the fund as mentioned in sub-clause (iii) of clause (c) in any Scheduled Bank as the Society may deem fit.
 - (e) To meet the expenses of the Society including expenditure in the exercise of its powers and discharge of its functions within the approved budget/funds.
 - (f) To maintain proper accounts and other relevant records and prepare an annual statement of accounts including the balance sheet in such form as may be devised by the auditors of the Society subject to specific instructions, if any, of the State Government.

To forward copies of such accounts annually prepared to the following as (g) certified by the Chartered Accountant appointed by the Society with the approval of the State Government:

(i) the State Government; and

- (ii) any other Department/Agency as may be decided by the State Government.
- To make such steps that may be necessary, incidental or conducive to the attainment of all or any of the objectives of the Society.
- To constitute such committee or committees/Sub-Committees/Selection Board, as it may deem fit, for the disposal of any business of the Institute or for rendering advice in any matter pertaining to the Institute.
- (j) To delegate its power to its committees or to any officers of the Society.
- (a) The control and management including financial management of the College shall vest in a Board of Governors (hereinafter referred to as "the Board")consisting of 11 members, which shall be constituted as under:

- (b) The first Director/ Principal of the College shall be appointed by the State Government and the succeeding Director/Principals shall be appointed by the Board.
- (c) The Memorandum and Rules and Regulations of the Board shall be made and may be amended or enlarged from time to time by mutual consultation between the Board and the State Government.
- 5 Admission to various courses offered by the College shall be made as per the procedure approved by the State Government.
- 6 The courses and syllabi in the College shall be approved by the concerned affiliating University and as per the guidelines of State Government.
- 7 The fees and other charges to be realized from the students of the College shall be prescribed by the Department of Technical Education, Haryana.
- 8 No donations or capitation fee or financial gifts shall be received or demanded from the students or their parents or guardians as an inducement for admission or after admission to the institute.
- 9 All disputes and differences arising between the parties out of or in any way touching or concerning this agreement whatsoever shall be referred to the Financial Commissioner and Principal Secretary to Government, Haryana, Technical Education Department, whose decision in the matter shall be final.
